Membership Update:

There are now 238 member households in TLRA, which includes 8 new members in the last year and 4 more already in '23. Please help us educate all our new members. (All have received copies of the TLRA Rules & Regulation's.)

Boat Stickers:

2023 boat stickers will be mailed out by the first part of May. Please put 2 of these on all your watercraft and trailers as this is the only way we have of monitoring lake use by members, and it helps in returning "lost" boats.

Matching Funds Projects and Erosion Control

For 2023, all shoreline projects are on hold pending a LWRC update. (Larimer & Weld Reservoir Company) The Terry Point erosion project is currently being reviewed by the LWRC engineers. LWRC will provide the heavy equipment to place the rock at Terry Point around the first of April.

Thanks to the 69 households who donated \$7624 towards this project which is added to the \$2856 from the Larimer County grant and an additional \$5311 from TLRA.

Fish stocking:

Fingerling walleye and perch were stocked in Terry Lake in October of 2022.

RULES and REGULATIONS - REMINDERS:

- 1. Dogs on any TLRA leased property MUST be on a leash or under voice command! For any problem animals, take a photo if possible, and promptly call Larimer Humane Society at 970-226-3647 or Sheriff at 970-498-5100.
- 2. All boats and trailers on TLRA property must have current stickers.
- 3. All guests on TLRA property MUST be accompanied by a TLRA member and NO guest boats are allowed.
- 4. If you are renting your property, the renters' names and contact info need to be on file with TLRA.
- 5. A plan for any shoreline project MUST be submitted to the TLRA board using the form found on TLRA.co.
- 6. Please do not dump yard waste on TLRA leased property! (Take it to Ewing's or the Larimer County Landfill.)
- 7. ALL lake activities are use at your own risk!
- 8. Caution on the ice!!! Stay away from the outlet area as it is unsafe!!!
- 9. The island is off limits from March 1 August 1.
- 10. Please remember that TLRA adheres to all CPW rules and regulations regarding fishing and boating.
