- C. Tree removal on Terry Shore walking path Charlie Get Charlie a check for reimbursement Charlie emailed Jack a copy of the receipt for \$400 and Jack mailed him a check for reimbursement.
- D. Douglas Road waterline project update Several meetings cancelled and rescheduled for? Lynn and Peggy who are part of the Thornton Pipeline Dream group will come to a future meeting to update us. Mark Heiden who lives in the Eagle Lake Area is evidently a big supporter of the Douglas Road pipeline and rumor has it that he was instrumental in getting the pipeline to go down Douglas and not N through Eagle Lake. - E. The question about hunting on Terry Lake is "No". Our lease only gives us the right to fish, sail, paddle and swim in Terry Lake and to walk along the shoreline.

The price went down slightly from 2017 which was \$7784.
