- C. Terry Point projects Todd
 - Barrier poles and seeding of path will be completed this spring.
 A second vote on email was done about the poles placement. This was done the last week of March to approve the poles placement. The vote was unanimous to place the poles in the right of way from the Terry Point beach to the West along the leased land.
 - 2. Swim buoys around dock needed. Todd will research costs and report back.
 - 3. Terry Point neighbors will be working on a new access gate to the beach and perhaps new signage as well.
- D. Erosion Project & County Grant
 - 1. Project plan, dates, etc. Depending on water level, work will probably begin around early September. Planning meetings will be held in July and August and will involve Eric Nacos(design engineer) as well as TLRA Board members ,neighbors and a representative from the conty.
