5. Old	d business :
A.	Discussion of proposed bylaws change/update – Jack – copies were handed out.

- B. Douglas Road waterline project December meeting The next meeting with the Larimer county commissioners will be December 18. All TLRA members are urged to attend.
- C. East side walking path/access road –update –Bob and Mike will be in contact with a road contractor, in the spring for possible repair.

D. 5 year meeting - (last held 12/4/13)

- 1. Need to choose a date. 12/10 if stay with Monday as in the past. 12/10/18 was chosen as the date for the 2018-5 year meeting.
- 2. Need to choose a location. The board chose to hold the meeting at Fire station #12 on the corner of Hwy.1 and Country Club Road.
- 3. Do we do a mass mailing or just post on website and have members talk with neighbors? The board decided to have a mailing of all members and include a vote proxy.
- 4. Need to create a ballot for the election of board members 1 from Hwy 1, 2 from Terry Shores, 1 from Terry Cove, 2 from Terry Point, and 1 from the west side. In the mailing, members were asked to turn in possible candidates by December 7 to Jack Lundt.
- 5. Need to create a proxy for those wanting to vote and not be present. This was added to the mailing.
- 6. Need to create an agenda. Jack will create one similar to that in 2013.
- E. Tamarisk spraying Charlie will check into timing of spraying.
- F. Fish stocking not done yet. No fish were available this fall at the last minute, so we will stock in 2019.
- G. Island erosion project update Dan spent 15 hours over 2 days with a tractor pushing soil up on the island to cover tree roots and to build a berm to slow down erosion. Michael Phelps, the reservoir superintendent stopped by to look at the progress and thought it was a great idea.

A. Terry Point shelter project – Todd K and Greg B presented the Terry Point shelter/boat storage project. This was cleared with the Hyland's and Guadagnoli's, the neighbors nearest to the project. They then asked for matching funds of \$804.79 for building materials.
