 - A. Website updates Kim & Phyllis
 - 1. New website looks good. Everything to be posted or added will go through Kim V.
 - 2. Problems/Concerns okay

- B. Trailer Park- Phyllis The correct term is a mobile home park. (There are 23 units and all but 2 are owned by Sandy Hutton.)
 - 1. Fencing status It is intact, but needs to be tightened up and a strand put back in place.
 - Contact info The manager is Stacey Meade and Phyllis will get her contact info. The owner is Sandy Hutton and she lives in Austin, Texas, and her phone is 512-796-7220. She is not interested in joining the lake as each of the 23 units would have to buy in, but she has her manager tell all renters that the lake is private.
 - Jack will draft a letter to all renters explaining that the lake is privately leased and they are not to trespass and hope that all renters will get a copy.
- C. Insurance costs \$7334.00 give a breakdown of cost and coverage
 - 1. Yes it does cover lawyer fees if needed.
 - 2. Does not cover algae poisoning and does not have a pollution coverage clause.
- D. Dues Mailing
 - 1. 236 letters were mailed out on March 1, 2017. Any questions ?
 - 2. This included 205 active, 19 inactive, and 11 nonmember households.
 - Side note on membership In 2013 there were 6 properties that changed hands, 2014 had 4, 2015 had 6 and 2016 had 22.(this included 8 properties added to the member list with the associated initiation fee.)
